BIDDER'S CHECKLIST

The following items are required to be submitted at the bid opening in order to be a qualified bid:

1. **Bid Form (001500)** – Signed (and sealed if corporation)
2. **Affidavit of Bidder (004800)** – Signed and notarized
3. **Non-Collusion Bid Affidavit & Business Relationship Affidavit (004850)** – signed and notarized
4. **Bid Guarantee** (five percent of bid proposal) – one of the following:
 - A. Certified Check
 - B. Cashier's Check
 - C. Bid Bond
 - D. Irrevocable Letter of Credit from a banking institution insured by F.D.I.C. of F.S.L.I.C.
5. Verify the receipt of all Addenda with the Construction Manager and note them on the Bid Form.
6. Verify the number of dates to complete work is noted on the Bid Form.
